AN ORDINANCE

"Establishing an Goffstown Economic Development Council in the Town of Goffstown".

Be it ordained, by the Board of Selectmen of the Town of Goffstown by and under the authority of the laws of the State of New Hampshire and the vote of the Annual Meeting of the Town of Goffstown for the year 1966, as follows:

Section 1: For the purpose of providing industrial, commercial, manufacturing and warehouse facilities in developing the growth and prosperity of the Town of Goffstown by encouraging the welfare of local industries and promoting the establishment of new industries, an Economic Development Council is hereby established.

Section 2: The Economic Development Council shall consist of nine (9) regular and two (2) alternate members. The nine (9) regular members shall include:

- a. Selectman (annual appointment as ex-officio member);
- b. Planning Board Chairman or designee (annual appointment as ex-officio member)
- c. Town Administrator or designee (until rescinded, ex-officio member)
- d. Six (6) regular members appointed by the Board of Selectmen (three year appointments)

Two alternate members will be appointed by the Board of Selectmen (three year appointments).

Section 3: The officers of the Goffstown Economic Development Council shall be a Chairman, Vice Chairman and a Secretary, who shall be elected by vote of the membership for a term of two years, but may be re-elected to such additional terms as may be desired by membership.

- (a) The Chairman shall preside at all meetings, shall appoint such committees as he or she is empowered to do so and shall carry out such other duties to him or her by vote of the membership.
- (b) The Vice-Chairman shall preside at meetings and generally carry out the duties of the Chairman in his or her absence, or upon his or her request.
- (c) The Secretary shall keep a true and accurate record of meetings and shall present it to the membership upon request.
- (d) The members of the Council may select some qualified person as an Industrial Agent and shall determine his or her compensation, subject to the approval by the Town of Goffstown of the amount of compensation as included in the regular budget for the
- (e) Town. Said industrial agent shall be the Chief Administrative Officer and shall have the power to appoint and discharge all other staff employees.

Section 4: The Economic Development council shall be and hereby is authorized to create one or more industrial corporations as provided in Chapter 292 of the Revised Statutes Annotated, having the authority conferred by such Chapter and Chapter 162D of said Revised Statutes Annotated; provided,


however, that such corporation or corporations shall, as may be consistent with the laws of the State of New Hampshire, be organized without capital stock, and shall provide that in the event of dissolution or the termination of the corporation all of the assets remaining after the discharge of all lawful obligations shall revert to and become the property of the Town of Goffstown.


Section 5: The Economic Development Council shall determine its own By-Laws, time and places and the conduct of its meetings, and may appoint by the Chairman such committees as may be necessary to carry out the purposes of this ordinance.


Section 6: Funds for the operation of the Economic Development Council shall be requested of the town of Goffstown and any appropriations received shall be expended according to the rules and regulations of the Town. Nothing herein shall be construed to mean that the Council is prevented from accepting funds from other sources.


Section 7: This Ordinance shall take effect upon its passage and all Ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Pursuant to the vote of the Town of Goffstown on March 8, 1966. authorized and directed the Board of Selectmen to establish by Ordinance the preceding Ordinance entitled "Establishing an Industrial council in the Town of Goffstown" has been enacted: enacted as a Town Ordinance of the 26th day of September, 1966, and as amended July 9, 2007.
